Position Summary:

The Head, Pharmacy Stores Services will oversee the pharmacy operations at St. Mary's Hospital Lacor, managing all activities related to the provision of drug and medical supplies, staff, facilities, and equipment to support effective and efficient delivery of care to patients. This role is responsible for medication and medical supply management, including procurement, inventory control, and distribution to hospital and peripheral health centers. He or she will ensure that essential medicines and medical supplies are available, well managed, and stored appropriately for cost-effective and high-quality inpatient and outpatient care. A track record of strong leadership and organizational skills, along with the ability to promote a culture of excellence and teamwork will take precedence over academic qualifications.

Key Responsibilities:

1. Strategic Leadership and Planning:

- Develop and implement strategic plans for pharmacy store operations to support the hospital's mission and clinical pharmacy activities to ensure optimal patient care.
- Lead the overall planning and forecasting for medication procurement, inventory management, and staffing needs.
- Continuously assess healthcare and community needs to adapt pharmacy strategies to improve patient access to medicines and outcomes.
- Establish and maintain policies and standard operating procedures to ensure high standards of regulatory compliance, logistics, supply chain management and distribution.
- Analyze performance data to drive decision-making and process improvements in pharmacy operations.

2. Human Resources and Training:

 Participate, together with the Head, Pharmacy Clinical Services, in the recruitment, training, and supervision of pharmacy staff in the pharmacy store, promoting professional growth and a collaborative work environment.

• Ensure pharmacy store team members are well-trained in procedures, roles and responsibilities, safety protocols, regulatory compliance, and customer service.

· Conduct performance evaluations and provide ongoing feedback to ID and other directors,

personnel officer and other stakeholders.

• Facilitate continuous education on medication management, medication safety and proper handling techniques.

3. Procurement, Inventory Management and Distribution:

Oversee the daily operations of the main pharmacy store to effectively (accurate and efficient)
deliver essential medicines and medical supplies to inpatient and outpatient services.

Maintain strict adherence to quality standards, proper storage, medication safety, hygiene

protocols, and medication and medical supply management best practices.

 Ensures that such products are stored in an area that is clean and organized with appropriate labelling, temperature, light, humidity, ventilation, regulation, security, and safety

 Ensures there is a method for identifying drugs/supplies that are outdated, deteriorated, recalled, obsolete, or hazardous, and that such products are disposed of in a safe, legal,

and environmentally sound manner.

Ensures that drugs are located in the area of the pharmacy appropriate to their drug classification and that storage areas are only accessed by designated personnel who are appropriately trained, including in other dispensing locations

Ensures record-keeping and documentation systems are in place for the procurement, movement and distribution/sale of drugs in a manner that is secure, auditable, traceable, and allows for their easy retrieval

Implement and monitor systems to track consumption, inventory levels, procurement, and

forecasting for both purchased and donated drugs

Monitor and manage expired stock

• Ensure policies and standard operating procedures (SOP's) are in place and up-to-date

• Ensures staff members whose duties include procurement, inventory management and distribution are appropriately trained

4. Financial and Budget Management in collaboration with the Finance and Cost-Controlling Departments:

• Contribute to the development and management of the main pharmacy store's budget, ensuring efficient use of resources and cost control in line with the hospital's approved pricing policies.

• Analyze utilization, performance data including revenue, expenditure, and cost management.

 Prepare regular financial and operational reports to the Institutional Director and Hospital Management.

Identify opportunities to optimize procurement processes and reduce medication costs.

• Implement corrective actions as needed to address discrepancies or safety issues.
